STANDING COMMITTEE REPORTS

Executive Committee – Commissioner Maas

Strategic Goal: Developed and implemented legislative Plan

- Thank you Campaign Update: Commissioner Maas thanked commissioners for their participation in the thank you campaign and the Senator's breakfast
- Commissioner Maas reviewed key items from recent Executive Committee meetings
- Senator's Breakfast: Commissioner Maas gave an update regarding the Senator's Breakfast event. Noting that it went well.
- ServeNebraska structure: The Commission is waiting for a date and time for LB910 to be heard by the Government, Military, and Veteran Affairs Committee. Commissioner Maas shared that Executive Director Plager and she met with Senator McDonnell the previous week. That meeting indicated that the bill does not yet have a date, the bill is pending an A-bill and fiscal note, and that the University of Nebraska had contacted the Senator requesting a reserved seat on the Commission be added to the bill. This seat would be in addition to the Nebraska Department of Education seat. Commissioner Maas also offered a special thanks to Commissioner King for his efforts meeting with senators in Lincoln.
- Strategic Planning: Commissioner Maas indicated that the final copy of the new strategic plan is
 housed on the commissioner portal. Agendas for committee meetings reflect the goals assigned
 to each committee. She noted that she, Commissioner Heilbrun, and Executive Director Plager
 meet on a regular basis to prepare for Commissioner Heilbrun's transition to commission chair
 in April.

AmeriCorps National Service Committee (ACTION) – Commissioner Worthington

<u>Strategic Goal:</u> Build and support quality, effective programs (program service) by implementing monitoring/tracking processes

- Program Updates: There are currently 15 programs. This includes 10 operational grants and 2 planning grantees for the 2021-2022 year as well as 3 VISTA grantees for 2022-2023. One organization, International Council for Refugees and Immigrants has both an operational and a VISTA program. Staff are also working with planning grants (United Way of the Midlands and the Department of Education) as they prepare to apply for operational grants.
- Policy Updates: The Committee reviewed and approved 3 AmeriCorps and 31 AmeriCorps VISTA
 policies and procedures. These policies and procedures were included on the consent agenda for
 the Commission meeting.
- Monitoring: Deputy Director Jackson is wrapping up monitoring of grantees and has sent out corrective action letters. All but 3 programs were issued corrective actions but there were no disallowed costs.
- Program Development Updates: Development Officer Lacy attended the Nebraska School Counselor Academy and the Nebraska State Education Conference in November to help boost awareness about AmeriCorps. This resulted in 7 school visits that will occur during this quarter.
- NOFO: ServeNebraska staff released the Formula Notice of Funding Opportunity. The formula NOFO will be open from January 3rd 2022 to February 28th 2022.
- Competitive Grant Application: ServeNebraska received one competitive grant application from College Possible. The Committee approved the College Possible competitive funding application for 30 AmeriCorps members with an investment of \$648,000. They are also switching from a fixed grant to a cost reimbursement grant, which will not result in any program design changes but will make it easier for them to expand their grant funding.

Motion #2: A motion to approve the Competitive funding recommendation was made by the AmeriCorps National Service committee.

No Second is needed

No discussion. A roll call vote was taken.

• The Committee approved 3 new VISTA host sites for 5 VISTA slots. In the future, the Committee will review VISTA applications and bring them to the Commission for final approval. Those VISTA host sites are:

Omaha Earned Income Tax Credit Coalition through the Family Housing Advisory Services - Omaha EITC Outreach Capacity Builder VISTA (2), recruit/train volunteers plus build awareness in community about services

International Council for Refugees and Immigrants - Communications and Public Relations Specialist VISTA and Development Coordinator VISTA (2), recruit/train volunteers plus build awareness in community about services, one do fundraising/applying for grants

Omaha Zoo Foundation – Lee G. Simmons Wildlife and Conservation Park in Ashland - STEM Career Ladder VISTA, recruit volunteers to grow their free and inclusive educational programming, building a career ladder

The VISTA member term will run from 02/14/2022 through 2/14/2023 providing full time service. Development Officer Lacy has developed the VISTA program and created training for the Host Sites.

Motion #3: A motion to approve the VISTA applications was made by the AmeriCorps National Service committee.

No Second was needed

No discussion. A roll call vote was taken.

Finance Committee – (ACTION) – Commissioner Hovey

<u>Strategic Goal:</u> Assess & strengthen funding models/processes to ensure sustainability of new funding streams

- Budgets/Expenditure Reports: Commissioner Hovey provided a review of expenditures and the states of all accounts. She also indicated imminent expenditures. No cost extension has been requested for program evaluation training and cohorts for AmeriCorps programs. Match has been met. Commissioners discussed methods for submitting/accepting donations through the Nebraska Community Foundation account.
- Budgets 2022: Committee reviewed the 2022 Commission support grant and Commission Investment fund grant and Foundation budget. Committee approved all 3 budgets.
- Status Report: Deputy Director Jackson provided an update regarding Fiscal Year 2021 AmeriCorps programs expenditures and statistical benchmarks that must be meet.
- Update on Criminal History Disallowance: Commissioner Hovey indicated that the Debt Resolution team at AmeriCorps sent a final letter and disallowed amount that one of

the programs must pay back to the treasury in the amount of \$11,155.81. Certified mail went out on 1/18/22 with the check for payback.

- VISTA: Commissioner Hovey indicated that VISTA MOA's are signed and payments have been made all expect for one project. She also reminded that the plan to move money from 0073 into 0068 will not be possible per accounting and budget, Deputy Director Jackson will track VISTA funds.
- Commissioner Hovey gave an update on 2022 Commission Administrative Budgets.

Motion #3: Committee moved to accept the budgets as presented.

Commissioner Nestor seconded.

Commissioners discussed whether 2021 fiscal coding confusion had been resolved. Deputy Director Jackson confirmed.

A roll call vote was taken.

Vote: 11- Yes; 0 - No; 0 - Abstained. Motion carried.

Community Volunteer Committee – Commissioner Heilbrun

<u>Strategic Goal:</u> Developed Intentional, well-educated partnerships with stakeholders & public

- Step Forward Awards: Commissioner Heilbrun provided a report on the results of the 2021 Step Forward Awards event which took place on 12/09/2021. She also noted that the 2022 Step Forward Awards event planning is underway and requested that fellow commissioners assist with publicity.
- Marketing update: Commissioner Heilbrun indicated that the Because of AmeriCorps campaign is running and that the AmeriCorps Is campaign from 2021 was a success.

- Select nominating committee for Vice Chair: Commissioner Maas called for volunteers for the nominating committee. Commissioners Hiatt, Heilbrun, and Maas were put forward.

Motion #4: Commissioner Maas moved to accept the nominating committee as presented. Commissioner Hall seconded.
